FROM ROUTE 80 EAST AND WEST:

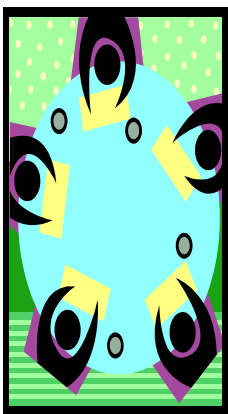
